An on-site inspection was held following the physical closure of the project and the submittal of the closing report and closing payments request. The running period of the project began from 3 November 2015, during which period the Foundation is obliged to uphold the operation of the OK Centre. The Foundation carried out its financial-economic education activity not only in the education centre set up in the framework of the programme, but achieved a national coverage as well, reaching convergence regions in a disadvantaged situation as well. 24,000 students from 160 schools took part in the programme's free, cooperative, inspirational trainings. With its knowledge transfer and the shaping of awareness programmes (for instance, workshops, thematic days, festivals, camps, school days) the OK Centre reached some 30,000 people (youths, families, experts, teachers).

In the framework of the project the Foundation accepted to employ 5 full-time staff (with higher education qualifications under the age of 30 who prior to the programme were lastingly unemployed) for a 12-month period, and to further employ them without support for a subsequent 3-month period in Nyíregyháza. The assistance was fundamentally used to cover their wage and contribution costs and ensured a smaller sum for services. The costs of utilisation also include accounted depreciation.				

Presentation of main activities and programmes in the business year

In the prior year the specially prepared trainers held various financial, economic and management trainings for primary and secondary-school pupils. The special trainings assist the effective transfer of knowledge with their inspirational and cooperative methodology. The Foundation reached more than 4,500 young people with its 4-hour and free trainings in Nyíregyháza and its vicinity (convergence region), by using its own vehicles and modern means. It also reached an additional several thousand students at various city events and events organised by the Foundation (directly and indirectly).

The project was launched in September 2014. The Foundation takes part in the project as coordinator, 2 Slovak and 2 Romanian schools take part as partners in the implementation. Four new training modules were developed that focus on European Union knowledge. E-learning materials were also prepared to complement the 4 new modules. The adaptation and recasting of the content of certain existing training modules for the Romanian and Slovak economic-educational environment and culture was carried out. The pilot trainings were held in September 2015. A successful multiplication programme and a project meeting were also held.

Presentation of main activities and programmes in the business year

Four new training modules were developed in 2015 in the topics of European Union basic, and European Union economic knowledge. The e-learning curricula related to the 4 new modules were also completed. The Romanian and Slovak adaptation of modules for pupils in grades 5-8 and 9-12 was realised in 2015, the adaptation of the new modules is in progress. Translation of the Romanian adapted versions for grades 9-12 was completed in 2015, translation of the other modules is continuing. We tested the new modules in the framework of pilot trainings in September 2015. Research is carried out parallel to the trainings: students take part in questionnaire surveys, teachers in in-depth interview research regarding content and methodology alike.

The Foundation began realisation of the project in September 2015, in which it sees to coordinator tasks, while a Romanian foundation takes part as partner. The partners in the project accepted to hold international project meetings, organise multiplication programmes, carry out sociological research, and develop and adapt a career programme. The current year utilisation basically implied the wage costs related to these and the costs of the project meetings. The coordinator and the partners fulfil accounting based on recognised cost flat rate.

Presentation of main activities and programmes in the business year

Launching the project and its professional preparation was the priority during the 4-month period in 2015, thus an international project meeting was held in September. The project focuses on the inspirational and entertaining, so-called OK Career Program developed by the Foundation for primary and secondary-school students, which is based on the OK method. The aim of the Career Program is to boost the self-knowledge of young people and to identify career possibilities that accord to their capabilities and competencies. An attitude survey took place in Romania which was a secondary research ad primary survey about the expectations of young Romanians about their careers and conscious planning of the future.

During the support period, a total of 200 students in 5 shifts took part in the Fáy Economic Camp's programmes based on inspirational, interactive trainings, and entertaining and health protection programmes. The Foundation ensured free participation from the support amount to those attending. The camping environment perfectly served the economic camp, the equipment in the classrooms, their situation, the quality of rooms and the services provided ensured the high level of the programme. Apart from the accommodation and meal costs the transfer of knowledge was also ensured through mini and adventure programmes.

Presentation of main activities and programmes in the business year

The Fáy Economic Camp was attended by students aged 14 to 17 who had good academic results and/or live in difficult financial circumstances, were at a disadvantage or multiple disadvantages, who came from various parts of the country: Nyíregyháza, Sopron, Kiskuhalas, Gyula, Szombathely, Miskolc, Mezőkövesd, Pusztaszabolcs, Budapest and Székesfehérvár. The support was used to cover the costs of student accommodations and meals, travels and various programmes. The Foundation ensured the costs of staff needed to realise the programme, as well as the applied methodology and training modules. The aim of the trainings is to make the topics of financial management and consciousness more understandable for the age-group with the OK methodology tailored to them, as this has major effects on society.

The BanKing card game's development was realised in the first half of 2015 through the cooperation of			

The BanKing card game's development was realised in the first half of 2015 through the cooperation of the National Bank and the Foundation. The planning and production of a family management board game was realised in the framework of the programme. Following the production of a classic card game and rules of the game, and a testing period, the game was provided to 7,500 families free of charge. The game was successfully received by both the public and the profession. A mobile app has also been prepared from the game, which is accessible for all, free of charge.

Presentation of main activities and programmes in the business year

When developing the BanKing card game, the goal was to create a board game that serves to fill a void and is for the entire family, and special emphasis was placed on the set of rules so that they cover all possible situations in life. The most important element of BanKing is to present the fundamental financial products and clarify their roles. The rules ensure scope of movement to the players, the system of rules can be expanded. Apart from the rules, the card-box also includes a mini "smart aleck" glossary that promotes understanding of the basic financial notions. The game was tested with the participation of several age-groups on many occasions. The advantage of BanKing is not merely that it is an IT-based game, but exists in a physical form, too, thus the experience is not limited to a screen. Regarding its social usefulness, the telephone application has a community building, knowledge sharing role and ensures the familiarisation of the basic financial notions.

The programme realised in 2015 can be divided into two parts: in the first half, students arrived in the Budapest OK Education Centre from villages along the Tisza River on a total 10 occasions. During an all-day adventure programme financial, economic and management education took place in a playful manner, accompanied by a programme at the Zoo and sightseeing in Budapest. The travel, meals, trainings and adventure programmes for participants were free. In the second half of the programme teachers were prepared for the teaching of financial and economic knowledge. The wage costs and curriculum and methodology of the programme was ensured by the Foundation from its own sources.

Presentation of main activities and programmes in the business year

The financial, economic and management training of some 400 primary school students living in the micro-regions was realised in a special manner – as an excursion to Budapest - in the education programme aimed at familiarising financial knowledge. Apart from shaping the conscious future approach of the students, the main goal of management trainings was to clarify and intensify the basic financial notions, their intensification was realised through playful, practical examples. The financial approach of the participating children was expanded during the adventure programmes in an interactive, inspirational manner. The programme also undertook the training of teachers in the micro-region for teaching financial, economic and management knowledge. The aim of the programme is for those taking part in the education of children to recognise the importance and foundations of financial education and to be familiarised with more effective methodological elements.
